### **Late Fee:**

A fee of 1.5% will be applied, monthly, for all delinquent dues, assessments and fees for all new charges incurred as of March 1<sup>st</sup>, 2012. **Late fees are applied to all outstanding past due balances after March 31<sup>st</sup>, 2024.**

**Unpaid Account Balances:** Unpaid account balances after May 1<sup>st</sup> are subject to referral to collections. Accounts referred to collections will incur additional fees and collections costs as follows:

**Account Maintenance Fee:** (New collections accounts as of 1/1/2022) \$250.00

**Collections Cost:** up to 30% of the account balance + filing costs

**Potable Water Hook-up:** (charge for connection to community system) \$150.00

**Initiation Fee:** (New Owners, not an owner in previous 12 Months) \$1,000.00

**Transfer Fee:** (assessed on property that changes ownership) \$500.00

**Account Status/Statement Fee:** ( New effective 1/1/2022 for Buyer Closings) \$75.00

**Non-Pumped Septic Fee: NEW** \$350.00

*Will be assessed beginning with the 2024 Dues Bill for any properties that have not supplied documentation to the Office confirming their septic has been pumped in the previous three (3) years (2012, 2022, 2023) or for newer systems that require regular maintenance inspections, a copy of the inspection report By December 31<sup>st</sup> 2023.*

*Member assessed in 2024 have an extended grace period to get a credit on the fee if they provide proof of compliance by June 30<sup>th</sup> 2024. There will be no refunds.*
